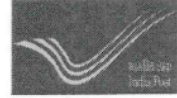

Subject: Notification for recruitment of Staff Car Driver (Ordinary Grade) in Madhya Pradesh Circle in the Department of Posts.

Applications are invited from the Indian Nationals in the Proforma (Annexure-I) for Direct Recruitment of Staff Car Driver (Ordinary Grade) (General Central Service, Group-C, Non-Gazetted, Non-Ministerial) from Open Market, in M.P. Circle.

2. Scale of Pay:

Post	Scale of Pay
Staff Car Driver (Ordinary Grade)	Rs. 19900-Rs 63200 in Level-2 as per Pay Matrix specified in Part A of schedule of CCS (Revised Pay) Rules 2016 plus admissible allowances [Rs 5200-20200 (Pay Band-1) + Grade Pay Rs 1900 under Pre-revised scale].

3. Vacancies : The category-wise break up of vacancies is as follows:

* Vacancy reserved for Ex-SM will be filled up from any category and then be adjusted horizontally against respective category viz UR/EWS/SC/ST/OBC as the case may be depending upon category to which selected candidate belongs to, that means vacancy earmarked for Ex-serviceman is included within total vacancies

4. Age limit : Between 18 to 27 years. Relaxation will be provided as under in respect of vacancy reserved for them.

For OBC Candidate	Relaxable upto 03 years
For SC/ST Candidate	Relaxable upto 05 years
For Central Government Servant	Up to age of 40 years
For Ex-Serviceman	Up to a maximum of 3 years [08(3+5) years for SC & ST and 06 (3+3) years for OBC] after deduction of the Military Service rendered from the actual age.

1. The Candidate availing reservation must submit their caste certificate in the prescribed format appended as Annexure II, III & IV.
2. The last date for receipt of application is on or before **24.11.2023** by 17.00 hrs.
3. The crucial date for determining the age-limit is closing date for receipt of application forms (i.e. 24.11.2023)

5. **Probation Period** : The candidates selected will be on probation of two years as per rules.

6. **Educational and other qualifications:**

- a. Possession of a valid driving license for light & heavy motor vehicles.
- b. Knowledge of Motor mechanism. (The candidate should be able to remove minor defects in vehicle).
- c. Experience of driving Light & Heavy motor vehicles for at least three years
- d. **Pass in 10th standard** from a recognized Board or Institute.
- e. **Desirable qualification-** Three years' service as Home Guard or Civil Volunteers.

8. Criteria for selection:

- Candidates qualifying in Stage-I shall be eligible to appear for test in Stage-II.
- Only such candidates who qualify in each paper of Stage-II shall be considered for preparation of final merit list.
- Final merit list of the qualified candidates shall be prepared on the basis of total marks secured by the candidates in both the stage of examination.
- After arranging the candidates in order of merit as per (c) above, number of candidates to be declared successful shall be equal to the number of vacancies in each category.



- e. In the event of any vacancy notified for recruitment remains unfilled due to non-joining of selected candidates, the next candidate in the merit list shall be considered for appointment. However, appointment of such candidate shall be only on refusal / declining offer of appointment and no wait list or approved panel shall be maintained.

Note: The date and venue of the tests will be intimated separately to the eligible candidates. No intimation will be sent in respect of other applicants who are not eligible.

9. Disqualification: No Person

- a. Who has entered into or contracted a marriage with a person having a spouse living; or
b. Who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this Rule.

10. Disclaimer:

- a. The Department of Posts reserves the right to cancel this recruitment process without assigning any reason.
b. The vacancies notified are subject to change without assigning any reasons and Department reserves the right to cancel the recruitment.

11. Special instructions to the candidates

- a. The candidates should fill up all the fields of the application forms **enclosed Annexure-I . The form should be downloaded from India post website or MP Post website. Application purchased from outside vendors will not be accepted and summarily rejected without assigning any reason.**
b. Incomplete application form will be summarily rejected.
c. No column should be left blank
d. One envelope should contain one application only.
e. Along with the application form an Indian Postal Order For Rs.100/- from any Post Office should be enclosed as application fee. **Women candidates and candidates belonging to Scheduled Castes (SC), Scheduled Tribes (ST) and Ex-servicemen (ESM) eligible for reservation are exempted from payment of fee.**
f. The application complete in all respect should be sent through **SPEED POST/ REGISTERED POST only**. Those sent through others means, private couriers by unregistered post and given by hand etc. shall not be accepted.
g. Application received after due date will not be entertained under any circumstances. Incomplete, unsigned applications or applications without the required Annexures will be rejected summarily and no correspondence in the matter will be made with the applicant.
h. Application received without proof of date of birth will be rejected straightway.

- i. No allowances and expenses will be paid for attending the test and the candidates will have to bear the cost.
- j. Self-attested copies of all the documents, viz. (i) date of birth certificate, (ii) educational qualifications, (iii) Driving Experience Certificate (iv) Driving licence (v) Caste certificate, if any, etc. should invariably accompany the signed application form. Otherwise application will be rejected.
- k. The Documents / marks lists / certificates submitted at a later date will not be entertained. ORIGINAL CERTIFICATES should not be submitted. The selected candidates should produce relevant original certificates only at the time when it is called for.
- l. Community Certificate for SC/ST/OBC/EWS in the prescribed form (annexures enclosed) issued from the Competent Authority is to be submitted. Certificates submitted in any other form or from authorities not competent to issue the same will not be accepted.
- m. The candidates on appointment shall be liable for posting at any place in the Madhya Pradesh Circle.
- n. Further **cross signed colour passport size photograph**, shall also be pasted on the application form in the space provided for the purpose. Additional Photo to be pinned to the application form. Application form without cross signed photo will be summarily rejected.
- o. The Department reserves the right either to revise the number of vacancies or to cancel the recruitment, if so warranted.
- p. No correspondence in person, e-mail or telephone etc. will be made.
- q. Failure to comply with instruction / conditions prescribed in the notification, the application will be rejected and no intimation will be served. No communication in this regard will be entertained.

The eligible candidates may submit their applications only in the prescribed format in Annexure-I, affixing their recent passport size photograph, duly filled in along with enclosures & an Indian Postal Order for Rs.100/- from any Post Office should be enclosed as application fee in an envelope super scribed as "APPLICATION FOR RECRUITMENT TO THE POST OF STAFF CAR DRIVER (ORDINARY GRADE)" addressed to "Asstt Director (Estt/Rectt), O/o Chief Postmaster General, M.P.Circle Bhopal-462027" so as to reach on or before the last date i.e. 24.11.2023 by SPEED POST/REGISTERED POST ONLY. Application sent through private courier, unregistered post, ordinary mail, other means and by hand etc. will not be accepted.
